### Pogoji za mentorja in somentorja /Conditions for mentor and co-mentor:

Mentor ali somentor na doktorskem študiju je visokošolski učitelj UL, z nazivom docent, izredni profesor in redni profesor oziroma znanstveni delavec z nazivom znanstveni sodelavec, višji znanstveni sodelavec ali znanstveni svetnik in ima izkazano raziskovalno aktivnost z ustrežno bibliografijo s širšega področja teme doktorske disertacije./A mentor or co-mentor on doctoral studies shall be a higher education teacher of UL with the title of assistant professor, associate professor or professor or an academic researcher with the title of research associate, senior research senior research fellow and has demonstrated research activity with a relevant scientific bibliography in the broader field covered by the doctoral dissertation.

Mentor in somentor je lahko tudi oseba z ustrežno habilitacijo druge ustanove (domače ali tuje), ki ima reference s širšega področja teme doktorske disertacije, sodeluje v doktorskem študijskem programu ali je zaposlen na ustanovi, s katero ima UL ali Fakulteta sklenjen sporazum oziroma pogodbo o sodelovanju./ Researchers with the appropriate habilitation of another institute (domestic or foreign) may also be supervisors or co-supervisors. They must have references from the broader field of the doctoral dissertation topic, and work in a doctoral programme or be employed by an institution with whom the UL or a UL member has concluded an agreement or entered into a cooperation agreement.

Poleg osnovnih kriterijev je minimalni pogoj za izkazovanje raziskovalne aktivnosti mentorja/somentorja, skladno s sklepom Senata UL, št. 031-10/2018 z dne 9. 1. 2019, da v zadnjih petih letih doseže **150 Z točk po SICRIS** in hkrati doseže več kot 0 točk pri kazalcu pomembnih dosežkov **A 1/2**./In accordance with the decision by the Senate of the UL No. 031-10/2018 from 9. January 2019 in addition to the basic criteria, the minimum condition for a mentor/co-mentor to demonstrate her research activity is that during the last five years she has achieved 150 Z points according to SICRIS and is placed in the index of important achievements with a quantitative grade of A 1/2 more than 0.

Oseba je lahko mentor **največ šestim študentom**, ki so vpisani v katerikoli doktorski študijski program in od njihovega zadnje vpisa v letnik oziroma dodatno leto ni minilo več kot dve leti. V to število ne štejejo študenti, ki so oddali disertacijo v ocenjevanje. Ta omejitev velja tudi za somentorja. / One person may supervise or co-supervise a maximum of **six doctoral candidates** enrolled in any doctoral programme at the UL, and no more than two years have elapsed since their last enrolment in a year or additional year. That number shall not include doctoral candidates who have already submitted their dissertation for assessment.
