Cilji in kompetence:

Cilj predmeta je poglobljen študij zgodovinskega razvoja in obstoječih ureditev in prakse temeljnih institucij javne uprave v izbranih (skupinah) držav(ah). V tem okviru bodo poleg okvirnega prikaza temeljnih razvojnih tendenc razvoja držav/e in s tem njene/njihovih javne/ih uprav/e obravnavane tudi izbrane teme oblikovanja institucij javne uprave v različnih družbenih in zgodovinskih okoliščinah v Evropi in še posebej v Sloveniji. Pri tem bodo teme analizirane tako s perspektive upravne znanosti, upravnopravne znanosti in tudi drugih družboslovnih znanstvenih disciplin.

Študent pridobi sposobnost znanstvene analize problemov, vrednotenja različnih teoretičnih stališč in kritične analize upravnih sistemov in upravnopravnih institucij. Usposobi se za razumevanje in nadgradnjo upravno-teoretičnih znanj s poudarkom na statusni in funkcionalni opredelitev izvajalcev javnega upravljanja. Študent pridobi sposobnost kritične refleksije v raziskovanju v polju interdisciplinarnih ved in primerjalnega prava.

Predmet izhaja iz temeljnega področja upravnega prava in javne uprave, pri čemer se upošteva tesna povezanost predmeta z ostalimi upravnimi predmeti. Pri tem pa je v veliki meri delo študenta individualno, izbira in obravnava pravnih problemov na področju

Objectives and competences:

The course allows an in-depth study of the historical development and the existing regulation and practice of the basic institutions of public administration in selected (groups of) countries. In addition to an overview of the main trends of development of the country/countries and its/their public administration/-s, the course will cover selected topics regarding the development of public administration institutions in different social and historical circumstances in Europe and particularly in Slovenia. Such topics will be analysed both in terms of administrative science, administrative law science, and other social science disciplines.

Students will gain the capacity to scientifically analyse problems, evaluate different theoretical approaches, and critically scrutinise various administrative systems and institutions of administrative law. They will learn to understand and upgrade their theoretical knowledge of administration, with emphasis on the status and functional definition of public administration bodies. Students will gain the capacity of reflective research in interdisciplinary sciences and comparative law.

The course combines the basic elements of administrative law and public administration, with due consideration of its close relatedness with other

Predvideni študijski rezultati:

Študenti bodo podrobno razumeli vlogo javne uprave kot znanstvene discipline in kot predmeta proučevanja v sistemu javnega upravljanja skozi čas. Znali bodo evalvirati trende razvoja. Obvladovali bodo znanja za oblikovanje ustreznih javnih politik v evropskem prostoru. Študentje bodo pridobili metodološka znanja raziskovanja v stroki in znanosti.

Intended learning outcomes:

Students will understand the role of public administration as a scientific discipline and as an object of research in the system of public governance over time. They will be able to evaluate the trends of development. They will manage to design field public policies in European space. Students will acquire methodological skills to run professional and scientific research.

Metode poučevanja in učenja:

1. predmet bo sestavljen iz predavanj, seminarских vaj ter individualnega študijskega dela in raziskovanja,
2. predavanja – predavajo se izbrane teme, ki se določijo posebej glede na razvoj teorije, zakonodaje in sodne prakse,
3. seminarne vaje - na seminarских vajah študentje predstavijo vsebino seminarske naloge,
4. drugo – izdelava seminarske naloge, ki obravnava zahtevnejši pravni problem z navedenih področij,
5. individualni študij za izpit.

Learning and teaching methods:

1. The course will comprise lectures, tutorial as well as individual study and research
2. Lectures – on selected topics to be determined with due consideration of the development of theory, legislation and case law
3. Tutorial – students will present their seminar papers
4. Other – elaboration of a seminar paper dealing with a complex legal issue related to the selected topics
5. Individual study for exam
