The aim of the course is to:

- acquaint students with the human right to health;
- acquaint students with the meaning and importance of health system;
- acquaint students with the knowledge about the organization of health system;
- acquaint students with the knowledge of current issues in the field of health care.

Students should be able to generally understand:

- meaning and importance of the right to health;
- basic concepts of the health system;
- social justice and its role in health care;
- basic models of the health care;
- students should be able to critically analyse current situation in the health sector.

Študenti bodo razumeli osnovne koncepte zdravstvenega sistema, kar jim bo pomagalo razumeti njegovo strukturo in delovanje. Poleg tega bodo študenti razumeli tudi sodobna vprašanja na področju zdravstva in jih zmožni kritično analizirati.
